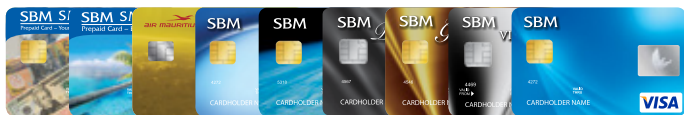

1. This SBM Card campaign is valid for the period starting from 6<sup>th</sup> March to 14<sup>th</sup> April 2018 (Both dates inclusive).

6. The promotion is open to all holders of SBM Visa cards only (Credit card, debit card and prepaid card)

  13. SBM Visa Business cardholders, minors and SBM employees are not eligible to participate in this campaign.
  14. Transactions made at Automatic Teller Machines (ATMs) and at bank counters i.e. all cash transactions will not be recorded and will not be considered for this campaign.
  15. Transactions effected through Top-up, Billpay, financial and gambling institutions will not be entered for this campaign.
  16. Customers may request for their lucky number(s) at any SBM branch or by calling on **207 0111** during weekdays from 08h00 - 18h00 by the end of April 2018.
  17. The draw will be carried out during the month of April 2018 at the Mauritius Turf Club in the presence of a representative of the Gambling Regulatory Authority and the winner will be subsequently contacted by phone.
  18. The winner will be responsible for ensuring that he/she and any person travelling with him/her are available to travel and hold valid passports, any necessary visas and travel documents for the holiday in question on the travel dates specified.
