7. A draw will be conducted for the period of 11<sup>th</sup> July 2025 to 6<sup>th</sup> October 2025.

17. Cash withdrawal using the SBM Visa cards shall be excluded for the purposes of this Visa Campaign.
18. Transactions pertaining to TopUp, Billpay, financial, gambling institutions and refund/reversal shall be excluded for the purposes of this Visa Campaign.
19. SBM Visa cards with arrears/delinquent accounts at the time of the draw shall be excluded for the purposes of the Visa Campaign.
